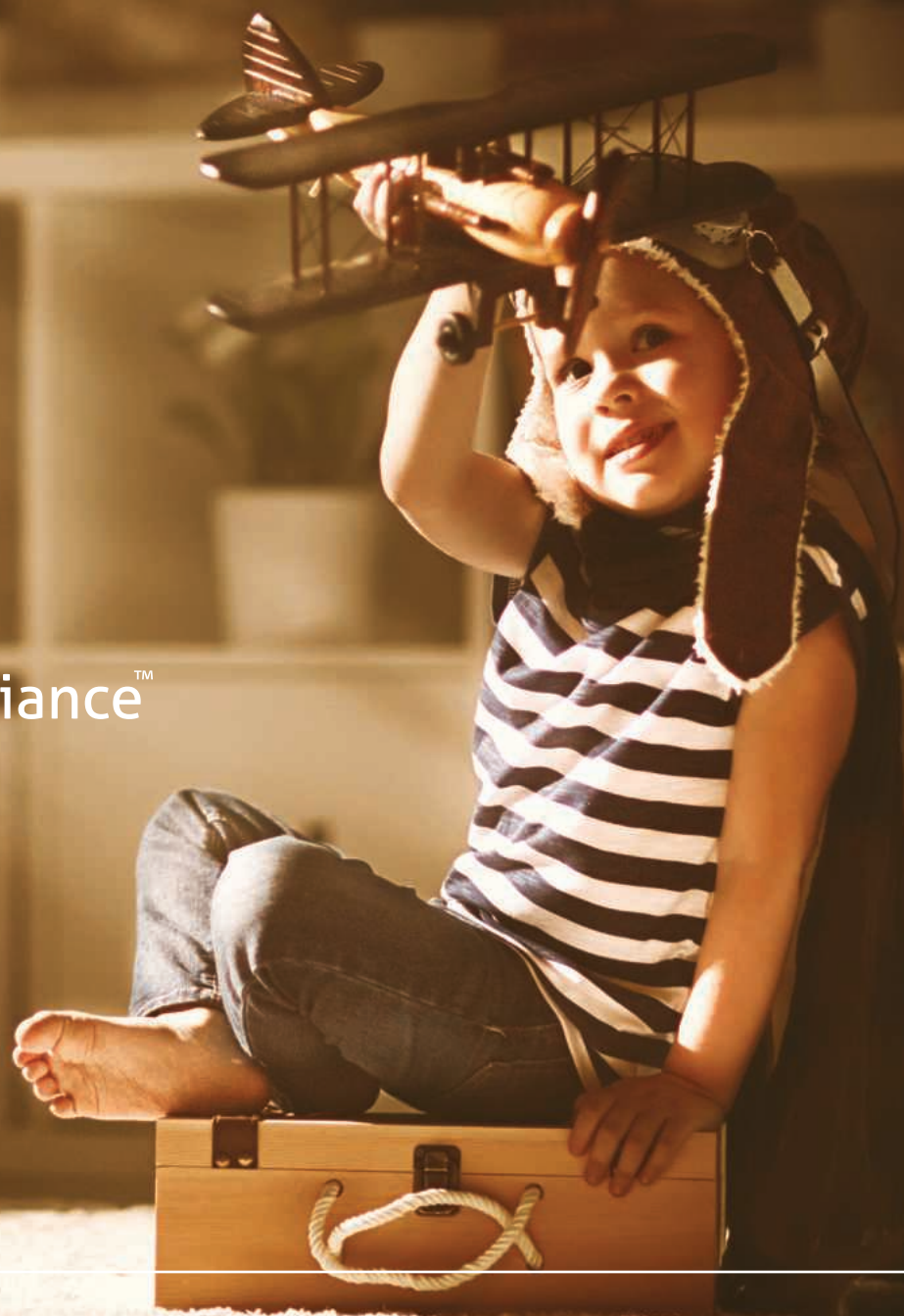

Last year GSCA along with member Child Advocacy Centers (CAC) across NH achieved several milestones contributing to improvements in our response to child abuse.


- GSCA released a public responsibility movement KNOW & TELL - knowing the signs of abuse and telling responsible authorities when you recognize them.
- Together we celebrated the accomplishment of all NH CACs earning national accreditation with the National Children's Alliance.
- We are proud of the development of a model CAC in Laconia where children will receive health services on-site through the support of agency partners.
- And with an increase in awarded funds, our CACs made improvements in staff capacity with the addition of Family Support Specialist positions to provide the highest-quality care to child victims of abuse and their families.

The momentum of 2016's successes gave us extraordinary motivation to look forward to 2017 and beyond as we ventured on a yearlong strategic planning initiative, Runway to 2021. The results of this work will positively affect the direction of our organization, our child protection system in NH and our CAC movement for the future. This report provides an introduction of who we are, what we do, and highlights where we are going.

This is the year to take the next step forward remaining dedicated to the tireless fight to assure that children and their families have a victim centered CAC experience in a safe and responsive place to move beyond their trauma to Heal, Survive and Thrive.

WHO WE ARE

The Granite State Children's Alliance (GSCA) is a statewide chapter organization dedicated to putting the needs of New Hampshire's child abuse victims first. Accredited by the National Children's Alliance, GSCA operates four Child Advocacy Centers (CACs),

directly serving the children of Belknap, Cheshire and Hillsborough Counties. GSCA also serves as the New Hampshire Chapter of the National Children's Alliance, providing technical assistance, training, and organizational resources to

all Child Advocacy Centers in the State.

Mission

Our mission is to provide all victims of child abuse in New Hampshire a neutral environment where justice, healing, equity and prevention are fostered through the consistent, high quality and sustaining collaboration of community partners.

History

Here is a brief overview of New Hampshire's Child Advocacy Center Movement.

- New Hampshire's efforts to better protect its children date back to 1983, when the New Hampshire State Senate established a committee to study the State's child protection system.
- Recommendations from that committee led to the creation of the Attorney General's Task Force on Child Abuse, which would ultimately inspire the creation of New Hampshire's first Child Advocacy Center, the Child Advocacy Center of Rockingham County.
- With the CAC of Rockingham County providing a successful model in 2001, Governor Craig Benson issued an executive order in July, 2003 to establish the Governor's Commission for Child Protection.
- In November, 2003, that Commission issued its findings and recommended the development of a statewide network of Child Advocacy Centers.
- Governor Benson and Attorney General Peter Heed then secured funding to help establish CACs in every county of the State, with the funding for each Center phasing down over a period of 5 years.
- Today, New Hampshire has 100 percent coverage with a CAC in every county; two in Hillsborough County and every CAC in NH is accredited with the National Children's Alliance.

WHAT IS A CAC?

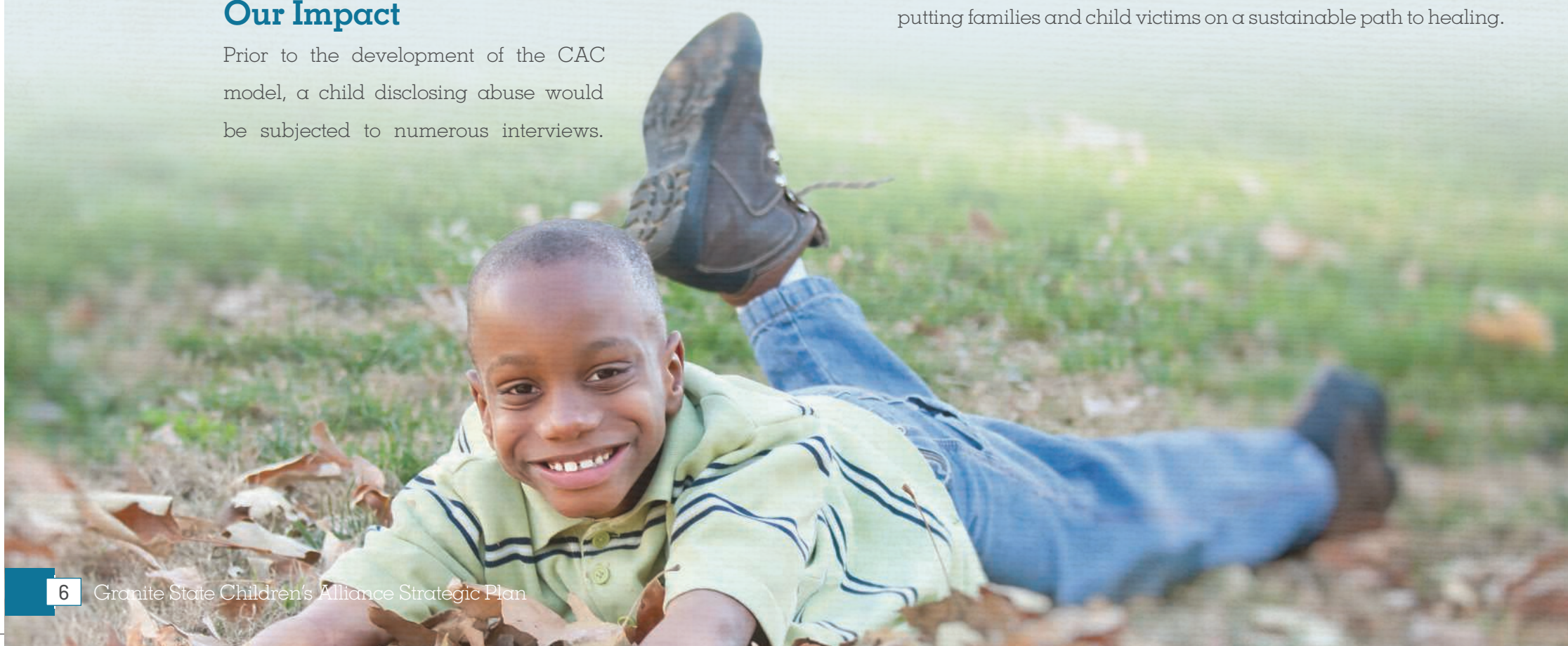
Based on a nationally recognized model, **New Hampshire's Child Advocacy Centers** are community partnerships dedicated to pursuing the truth in child abuse cases and coordinating social services for child victims. By bringing together our State's law enforcement, county attorneys, protective services, victim advocacy agencies and health professionals, New Hampshire's child advocacy centers provide safe, child friendly locations for interviewing child victims. Children are interviewed by a forensic interviewer. The forensic interviewer has special training and is experienced in talking with children.

Our Impact

Prior to the development of the CAC model, a child disclosing abuse would be subjected to numerous interviews.

The social service and the criminal justice systems, at that time, were not working together in an effective manner which added to children's emotional distress, and created a segmented, repetitious, and often frightening experience for child victims. Compounding this problem was the lack of communication between the professional disciplines involved. This resulted in child sex offenders not being held accountable for their crimes, leaving children and our community at serious risk.

The Granite State Children's Alliance seeks to break the cycle of abuse not only by seeking justice for child victims, but also by putting families and child victims on a sustainable path to healing.



A Different Approach

The Multi-Disciplinary Team (MDT) approach used at Child Advocacy Centers has been deemed best practice in the investigation of child abuse cases. This approach is coordinated by a CAC Forensic Interviewer and ensures all aspects of the case are examined and that efforts are coordinated between MDT professionals.

Our Partners

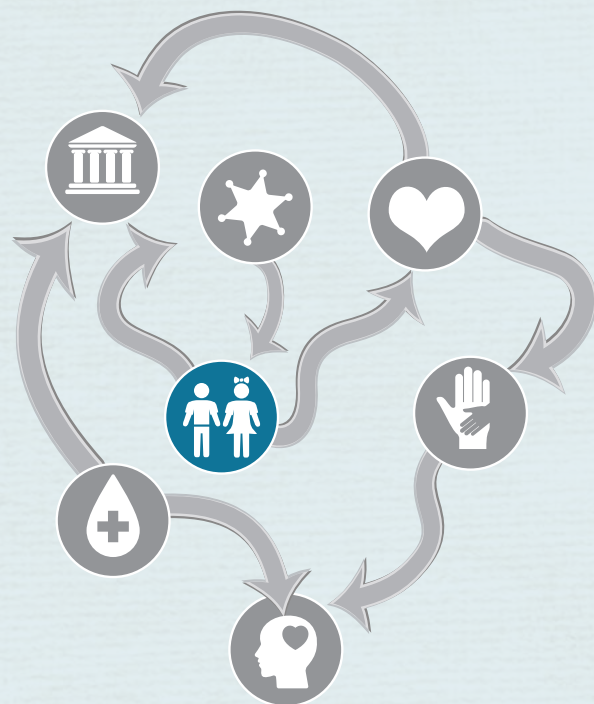
Professionals assigned to a Child Advocacy Center team specialize in the area of child abuse.

Our partners include:

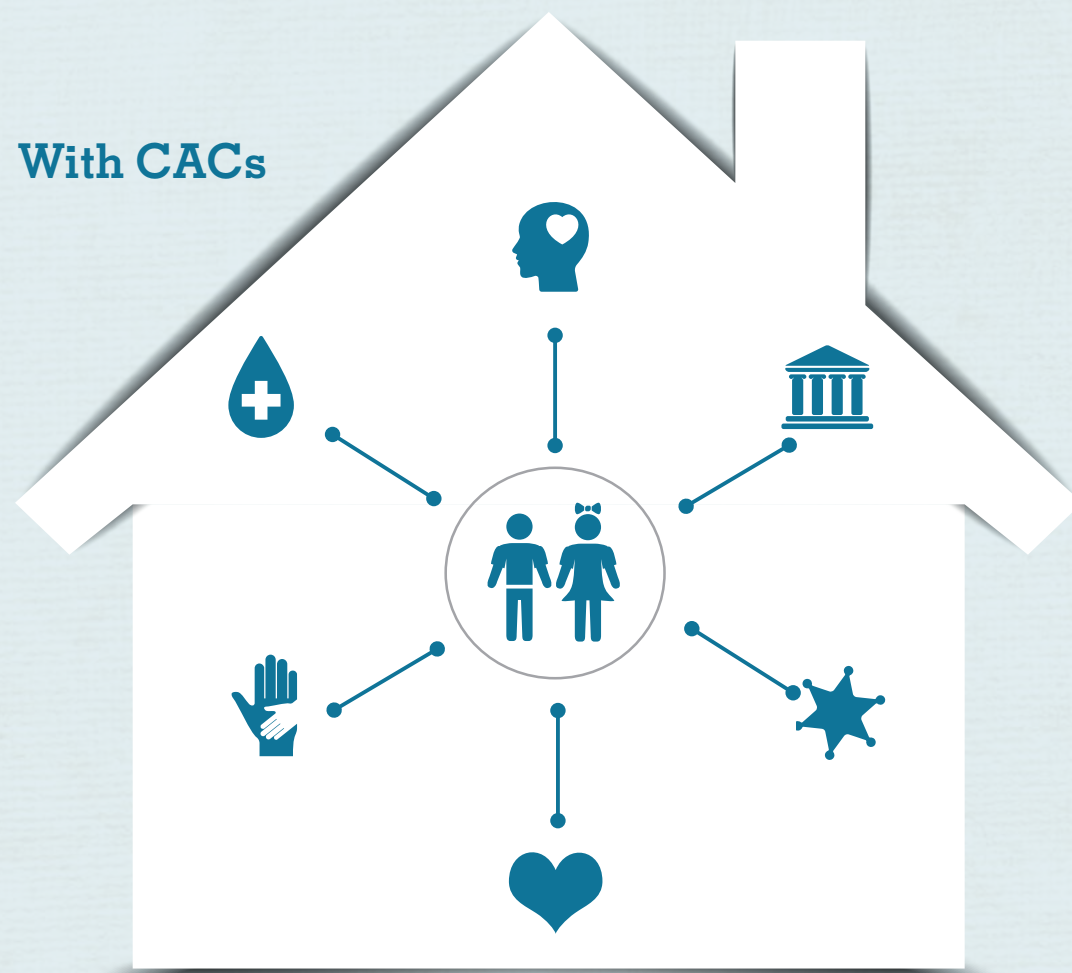
- **County Attorney/Prosecutors** – The county prosecutor leads the team and has the final decision as to whether charges will be filed. Prosecution may not happen in every case.
- **Law Enforcement** – Police Departments in New Hampshire assign investigators to their local Child Advocacy Center team. They interview children, non-offending parents, suspects and other witnesses and gather evidence from the scene of the alleged event.
- **Child Protective Services** – The role of the Division for Children, Youth and Families (DCYF) is to help protect children. The DCYF social workers conduct interviews with family members and develop safety plans. They may refer children and families to counseling or other support services within the community.
- **Medical Providers** – Physicians assigned to a Child Advocacy Center team have years of experience examining children for possible abuse. The exam may not prove if the child has been abused or not. Eighty percent of all children who have been abused have normal exams.
- **Crisis Center Advocates** – A crisis center advocate is available to provide support to non-offending parents/caregivers who have come with the child to the interview. The crisis center advocate is not part of the investigative team. They are a resource for support, referrals and information.
- **Victim/Witness Advocates** – Child Advocacy Centers work closely with the victim/witness programs at each County Attorney's Office. The victim/witness advocate attends the interview, tracks cases as they come in for prosecution, works with the family to prepare for a criminal case in court as well as provide other support services.

When police or child protective services believe a child is being abused, the child is brought to the CAC—a safe, child-focused environment—by a caregiver or other “safe” adult. At the CAC, the child tells their story once to a trained Forensic Interviewer who knows the right questions to ask in a way that does not re-traumatize the child. Then, a team that includes medical professionals, law enforcement, mental health, prosecution, child protective services, victim advocacy, and other professionals make decisions together about how to help the child based on the interview. CACs refer children to therapy and medical exams, victim advocacy, case management, and other services. This is called the multidisciplinary team (MDT) response and is a core part of the work of CACs.

CURRENT STATE

- **There are 11 Child Advocacy Centers in New Hampshire** – providing access to all children in the state. We have one in each county; Hillsborough County has two.
- **All New Hampshire CACs are accredited** with the **National Children's Alliance**
- There are **3 CAC Models** in New Hampshire:
 - Non-profit
 - County-based
 - Hospital-based
- On average, children referred to a CAC were interviewed for:
 - **Sexual abuse: 76%**
 - **Physical abuse: 17%**
 - **Other** (*witnessed a crime, neglect, etc.*): **11%**

Most children seen at CACs are **between the ages of 7 and 12 years old**

27% are between 0-6 years old

38% are between 7-12 years old

31% are between 12-18 years old

4% are Undisclosed

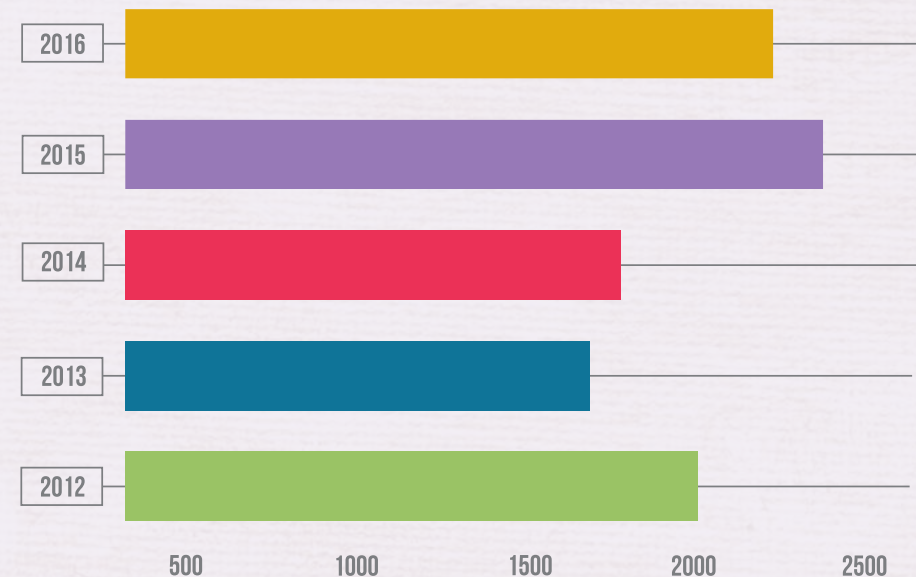

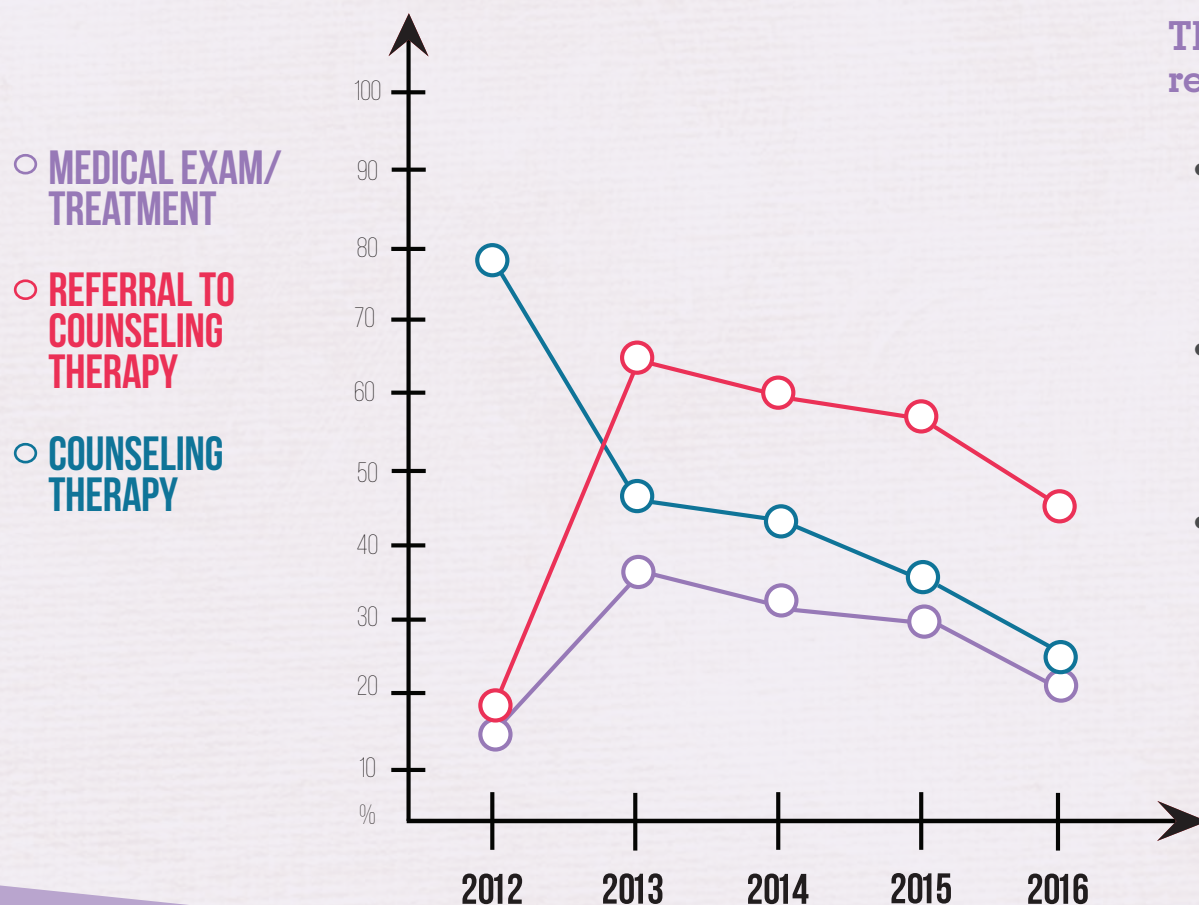

- **Medical Exams/Treatment**
733 of the 2,359 children (or 31% of children) received a medical exam or consultation
- **Referrals to Counseling/Therapy**
1,359 of the 2,359 children (or 58% of children) were referred for health assessment or treatment
- **Counseling/Therapy - Treatment**
777 of the 2,359 children (or 33% of children) received mental health treatment

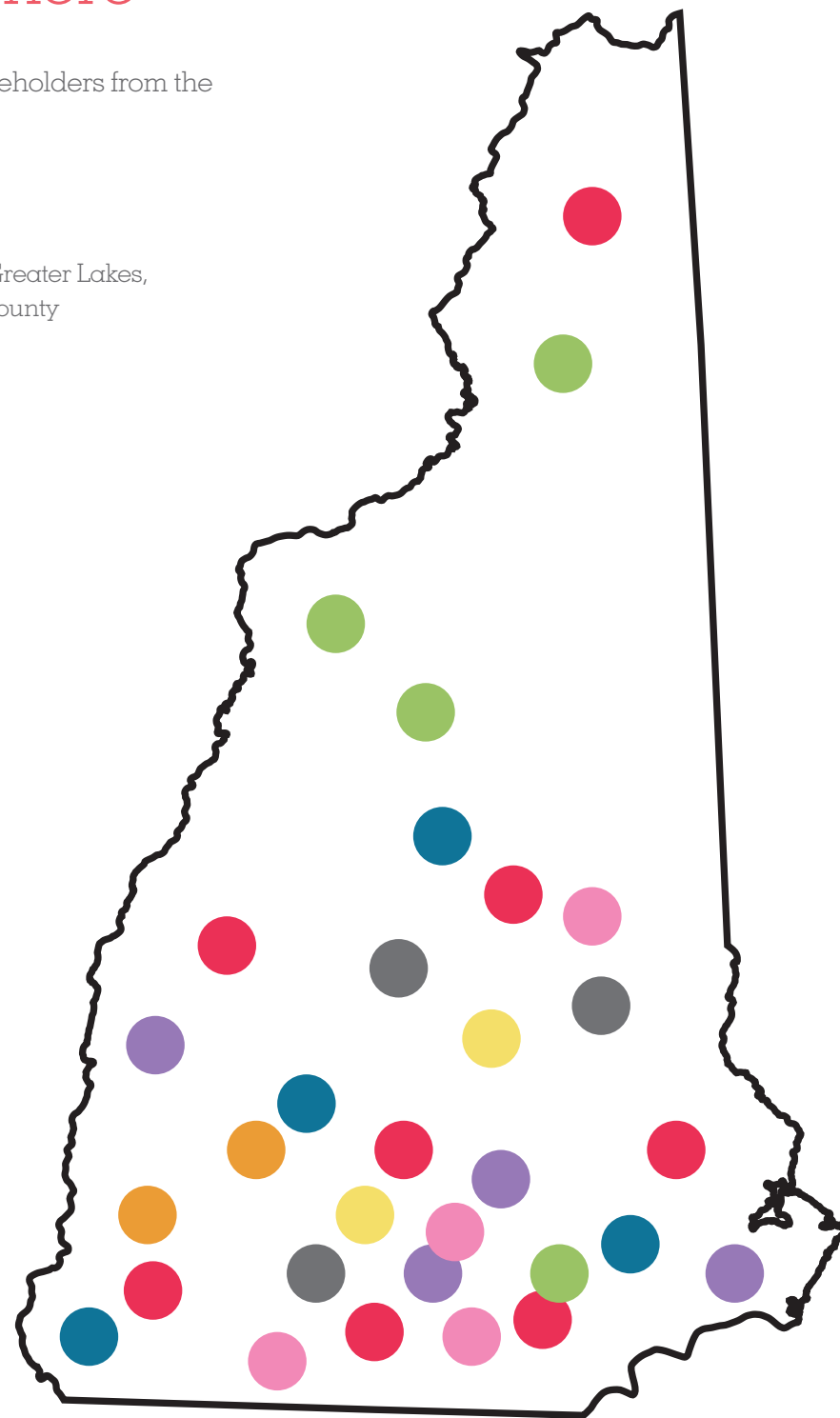

MEASURING RESULTS

GSCA and CACs in New Hampshire will measure outcomes and continue to improve the CAC experience for victims of abuse and their families moving forward.

The Outcome Measurement System (OMS) — What Does it Tell Us?

Child Advocacy Centers in NH utilize OMS to give families and team members a voice in the CAC process, which in turn allows centers to demonstrate their success and find areas for improvement. Through this evidence-based reporting process, CACs survey clients by collecting information to make sure that the services they provide to children and families—and the MDT model—are working.

OMS allows CACs to report on survey items designed to capture three measurable outcomes:

- Healing: Restoring the lives of children and families after abuse
- Justice: Striving toward collaborative and efficient case investigations supporting the CAC/MDT approach
- Trust: Ensuring children, families, and MDT members can trust their center and the CAC model

KNOW & TELL

The Granite State Children's Alliance created KNOW & TELL, a public responsibility movement to educate and empower adults to KNOW the signs of abuse and TELL responsible authorities when they recognize them.

April 20, 2016 Governor Maggie Hassan proclaimed KNOW & TELL day as a reminder that all NH adults are mandated reporters of child abuse and as Granite Staters we have a collective responsibility to keep children safe from abuse. Statistics show only 1 in 10 incidents of child abuse is reported by the child. Our message is if you KNOW or suspect abuse, step up and TELL responsible authorities. Leave the investigating to our experts who KNOW how to care for the most vulnerable in our communities.

KNOW & TELL is in the early stages of development and implementation as we work towards creating a robust program of materials, workshops and PSAs with the consistent message that we can all find the courage to report abuse, KNOW & TELL.

GSCA is also teaming up with the Crimes Against Children Research Center at UNH to measure the impact of KNOW & TELL in NH. This will enable GSCA to evaluate the effectiveness of KNOW & TELL and our marketing strategies at changing public attitudes toward mandated reporting and intervening on behalf of a child in need.
